### **IMPORTANT INFORMATION**

#### **MEMBER REGISTRATION:**

Application for FPEAK membership registration is Ksh. 20,000. This fee is payable once and not refundable even when a member leaves the association.

When a member is making their first-time application, they will be required to pay the registration fee plus the subscription fee for the quarter in which they are joining the association according to their FOB value as shown in the table below.

#### MEMBERSHIP SUBSCRIPTION:

- When a member joins the association, they are required to pay subscription fees payable on a quarterly basis (every three months).
- FPEAK subscription fees are calculated and categorized based on the members (exporter's) Free on Board (FOB) cash values.
- For as long as a member company is subscribed to FPEAK, it shall be required to make timely payments every first month of the subsequent quarter. Failure to pay will be a basis for the association to evaluate the membership.
- In the event that a member company wishes to leave the association it shall do so in writing addressed to the Chief Executive Officer through the provided FPEAK office emails.
