 - ix. In the event that for any reason there is stoppage of production with regard to the product described in this permit, the permit holder is obliged to notify the, Regional Manager/ Managing Director KEBS about the stoppage.
 - x. For Suspension of Permit, failure to stop usage of the standardization mark logo on the product and the permit no. shall be deemed as misuse of permit whether valid or expired and shall lead to demand to pay accrued monies in the period that renewal of same permit has not taken place.
